FORMAT

All levels to ride all 3 phases in the following order:

- **Dressage:** All levels will ride a Dressage test and then be scored and critiqued. Callers may be used.
- **Cross Country:** Supervised course walk. Rides will be timed to give a sense of pace.
- **Stadium:** Supervised course walk. Riders will ride a course, receive a critique and then ride the course again.

ENTRIES

Class 1-3: members \$40 / non-members \$50

Secretary / Office Fee: \$10 for each rider / horse combination entered

- Include a current Negative Coggins test or previous year (if tested within NYS), and a current rabies certificate with entry.
- Entries are limited to 25 riders. Preference given to CNYD&CTA members. If the show is oversubscribed a waiting list will be established.
- Entries process in order received by the post-marked "opening date" up to the post-marked "closing date".
- Incomplete entries will not be processed until complete.
- Refunds: less \$10 office fee, refunds after the closing dates are only available with medical certificate (horse or rider) received within 7 days of the show date.
- Use the CNYD&CTA Competition Entry form located in this Omnibus or available at www.cnydcta.org.
- Send entry to show secretary. Make checks payable to CNYD&CTA.

DIRECTIONS

From Rt. 20 – (between Cazenovia and Pompey) 2 miles North on Pompey Hollow Rd. Farm on right.

From Rt. 92 – (Between Manlius and Cazenovia) 1.5 miles South on Pompey Hollow Rd. Farm on left. **No dogs allowed.**

SCHOOLING

Following the event, the cross country course will be available for schooling for \$10 (one round only).

ATTIRE

Formal clinic attire is requested (boots, breeches or jodhpurs, gloves, polo shirt). ASTM/ SEI approved helmet is required. Medical Armband and X-C Safety Vest are strongly recommended for x-c phase.
